

"SUMMER FUN SWEEPSTAKES" TERMS AND CONDITIONS

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. VOID WHERE PROHIBITED.

The Pet Supplies 4 Less Summer Fun Sweepstakes ("Sweepstakes") begins at 12:00 a.m. CT on Monday, July 31, 2017, and ends at 10:59 p.m. CT on Sunday, August 13, 2017.

1. **Eligibility:** You must be at least 21 years of age to enter and a legal resident of the fifty (50) United States and the District of Columbia. Employees of Pet Supplies 4 Less (and the immediate families or members of the same household) are ineligible to win.
